- b) All the remittances are required to be completed by February 26, 2016 for The 13th; August 26, 2016 for The 14th. In case of cancellation, the payment is non-refundable under any circumstances.
- c)Please fax and mail the completed form together with the full participation fee to Fashion Marketing Department of Taiwan Textile Federation,13th Floor, No.22, AiGuo East Road, Taipei 10092, Taiwan on or before February 26, 2016 for The 13th; August 26, 2016 for The 14th.The organizer will send an invoice to the exhibitor.

8. Booth Allocation

- (1)The organizer will assign the booth number and booth site in accordance with the nature of exhibits, or in the manner the organizer deems appropriate.
- (2)If any assigned booth remains unoccupied on the opening day of the exhibition. The organizer reserves the right to re-assign it to other exhibitors or to arrange in any manner deemed suitable.

9. Registration and Confirmation

- (1) All manufacturers, distributors, traders and organizations involved in branded fashion apparel/ branded fashion accessories/Designer Labels/ Fashion Related Services are eligible to participate as exhibitors.
- (2) Acceptance of the application will be confirmed in writing by the organizer on a first-come, first-served basis. If the number of the requested booth exceeds the actual booths available, the organizer reserves the right to reduce the number and/or size of booths.

10. Terms of Application and Exhibition Regulations

- (1)Participation
 - a) Upon signing the application form, participants agree to obey all stipulated and further regulations.
 - b) The contract is effective as soon as it has been signed, submitted and confirmed.
- (2) Adherence to Copyright/Patent Law
 - a) It is strictly forbidden to display logo, licenses or patents that have already been registered by other companies.

b) Violation will result in immediate removal of the exhibits and two years suspension from all exhibitions in Taiwan. Exhibitors are responsible for all penalties without recourse or indemnity.

(3) Change of Venue and Show Dates

The organizer reserves the right to change the venue and the duration of the exhibition. In the event of change of the venue, dates, or cancellation of the exhibition, exhibitors shall not be entitled to any claim for compensation.

(4)Insurance

Besides insuring exhibits in-transit from the port to the exhibition site, exhibitors are also urged to adequately insure their properties on fire, theft, accident and third party liability during the exhibition period as well as the time their properties in the storages of the organizer's warehouse.

(5)Operation of Exhibition

- a) During show hours exhibitors shall keep their booths open and staffed at all times.
- b) Exhibitors are required to remain the booth's volume at a reasonable level and not to exceed 70 decibels.

6. Subletting of Booth(s)

Exhibitors are forbidden to assign, sublet or apportion the whole or any part of their booths, or have representatives, equipments or materials from other firms in their own booths without the written consent of the organizer.

7. Breach of Contract or Withdrawal

- a) If exhibitor refuses to use the whole or part of the booth reserved or allocated to him, or defaults in making payment on/before the designated date, the organizer has the right to terminate the contract forthwith and the payment shall not be refunded.
- b) In case of exhibitor's withdrawal from participation, the prepaid payment shall not be refunded.

8. Supplementary Clauses

- a) Whenever necessary, the organizer may add supplementary rules in addition to the above regulations.
- b) Additional written regulations shall constitute a part of the above-stated terms, Exhibitors' Manual and Contract for House show shall be viewed by exhibitors.
